## THE MALAYSIAN TECHNICAL COOPERATION PROGRAM (MTCP)

was first initiated at the First Commonwealth Heads of Government Regional Meeting (CHOGRM) for Asia Pacific Region in Sydney in February 1978. It was officially launched on 7 September 1980 at the 2nd CHOGRM in New Delhi, India, to signify Malaysia's commitment to South-South Cooperation, in particular Technical Cooperation among Developing Countries (TCDC).

The MTCP emphasises the development of human resources through the provision of training in various areas which are essential for a country's development such as public administration, good governance, health services, education, sustainable development, agriculture, trade and investment, ICT and banking. Since its inception in 1980, more than 34,000 participants from 144 recipient countries have benefited from the various programmes offered under the MTCP.

## COURSE OVERVIEW

Malaysia has reasonably well-developed set of infrastructure facilities. The Government had built on national infrastructure framework to promote economy development and to cater needs of the people. All categories of infrastructure have since expanded manifold and facilities have also been modernized. The development of infrastructure has required very large investments. The infrastructure sector has received the largest share of public sector development expenditure in every one of the Malaysia Plans. Private sectors are now actively involved in infrastructure development where the Government had line-out many incentives and programs that could facilitate this activity.

This course will provide platform for Malaysia professionals and contractors to share experience and to promote our capability in developing infrastructure projects. Some samples of Infrastructure projects are highways, bridges, airports, mass transit and urban transportation system, rail projects, water supply and water resources; wastewater management; solid-waste treatment and disposal; electric power generation and transmission and telecommunications. Malaysia has several infrastructure mega projects that could be promoted such as Tun Razak Exchange, Pan Borneo Highway, Light Rail Transit Line 3 (LRT3), Kuala Lumpur International Airport (KLIA 2) and etc.

## ADMISSION REQUIREMENTS

1. Selected government officials and technical experts from the ministries/governmental agencies involved in the planning, design, coordination and managing infrastructure development projects;
2. Possess education at least degree level and have at least 5 years working experience in the field related to the program;
3. Must demonstrate a good command of spoken and written English;
4. Have not participated in any MTCP, previously;
5. Must be certified medically fit and not pregnant.

MTCP application forms can also be obtained from the nearest Malaysian Embassy/High Commission in recipient countries.

Submitted application forms must be accompanied by the applicant's:

- Copy of Passport (Every pages)
- Passport sized coloured photo (3.5cm x 5cm)
- Medical Report

All application forms must be duly completed and endorsed by the Ministry of Foreign Affairs or National Focal/Aid Coordinator Agency in the respective countries and submitted ONLY through the diplomatic channel via the Embassy/High Commission of Malaysia.

**Successful candidates will be duly notified by CIDBH, one (1) month before the commencement of the course. Incomplete and/or unendorsed forms will not be processed.**

## COURSE FEE AND REGISTRATION

All course fees will be borne by the Malaysian Government under the MTCP.

## DAILY ALLOWANCE

Participants will be provided with a daily allowance of RM85.00 that is sufficient to cover daily expenses.

## MEDICAL & DENTAL TREATMENT

Medical treatments are provided at government hospitals/clinics only and the expenses will be borne by the Government of Malaysia under the MTCP. In case of an emergency, participants are eligible to be admitted to government hospitals/clinics. Dental treatments are restricted to extraction and filling only.

## VISA-WITH-REFERENCE (VDR) & VACCINATION

Course participants must comply with the Visa with Reference (VDR) application procedure to enter Malaysia. They must possess a valid passport or other internationally recognised travel document and visa, if necessary, valid for at least 6 months beyond the period of stay in Malaysia.

CIDBH will apply for VDR at the Department of Immigration, Malaysia and a copy of the VDR Approval Letter will be forwarded to the successful participants, subsequently with the copy of the approval letter, the participants must collect the VDR from the nearest Malaysian Embassy/High Commission.

Participants from some countries are required to take a mandatory vaccination for yellow fever at least 10 days prior to their departure to Malaysia. Yellow Fever certificate is required to be produced upon landing in Malaysia for countries as listed at the link below:

## AIRFARES

The Government of Malaysia shall provide excursion economy air ticket to all MTCP participants from the capital city of the MTCP recipient country to Kuala Lumpur and return air ticket from Kuala Lumpur to the capital city of the MTCP recipient country.

## ACCOMODATION & MEALS

Participants will be accommodated either in the hostel located in the vicinity of the Training Institutions or at the nearby hotels (twin sharing). Participants are strictly not allowed to bring any family members during the course. Food will be provided for the duration of the course.

## MANNERS

Participants shall conduct themselves at all times in a manner compatible with their responsibilities as MTCP participants and abide by the laws, rules and regulations as may be stipulated by the host government in respect of this training course.

## DRESS CODE

During lectures, male participants are required to dress in long-sleeved shirts with ties, long pants and lounge suits and female participants should be appropriately dressed in office attire. For formal occasions – lounge suit or national costume are required.
